Washington Department of Agriculture – Alison Halpern

- Alison gave the board updates about several projects WSDA is undertaking, the main topic being:
  - The need for an MOU between WSDA and NWCB to clarify roles to improve support.

# WSDA- Wendy DesCamp

- Wendy gave the board updates about several projects WSDA is undertaking, including:
  - o BLM, Spotted Lanternfly/Tree-of-heaven, and Biocontrol funding.
  - o New WSDA employees who were recently hired or will be hired soon
  - Flowering Rush
  - County-level weed distribution map update
  - NPDES permit

# Department of Ecology – Wes Glisson

• Wes gave the board updates about several projects his division at the Department of Ecology undertook in the 2023 season, including:

- New infestations of a few plants, including Floating primrose willow, European watermilfoil, yellow floating heart, and curly leaf pondweed
- Flowering rush management activities
- Aquatic invasive plant management grants
- o 2024 season planning

#### Washington Invasive Species Council – Stephanie Helms

- Sephanie gave the board updates on several WISC projects, including:
  - Invasive Species Awareness Week webinars and outreach booth in late February
  - Boot brush project in sagebrush steppe areas
  - WDFW funding for clean drain dry units
  - Bureau of Indian Affairs partnership for webinars and trainings
  - K-12 invasive species art contest

#### WSDA Pollinator Program – Katie Buckley

- Katie gave the board updates on a few projects the WSDA pollinator program is working on, including:
  - o Gave the weed board \$40,000 for seed packets this fiscal year only.
  - o A pollinator and noxious weed report will be finished by the end of 2024
  - o 2 significant pollinator bills went into law during the 2024 legislative session

# Department of Natural Resources – Todd Palzer and Brian Burgess

- Todd and Briand gave the board updates on the 2023 season at DNR. Some major projects they undertook were:
  - o Green Crab control
  - Spartina control
  - Lots of work with WCC crew

# Washington Department of Fish and Wildlife – Dave Heimer

- Dave updated the board on WDFW's 2023 season of invasive species projects, including:
  - Cattails and reed canary grass treated by drone
  - Diquat study on knotweed
  - Flowering rush control
  - Habitat restoration for Oregon spotted frog
  - Spartina management
  - Variable leaf milfoil treatment
  - Getting the pesticide advisory board running
- Dave also noted that he and his staff have seen feral holly being a problem on a lot of forest lands.

### Department of Transportation – Ray Willard, PLA, EPC

 Ray gave the board an update on the needs, hurdles, and projects his division is undertaking, including:

- That they are severely underfunded to keep up with maintenance needs and have been for over 10 years.
- Wildfire prevention
- Drone treatments of weeds
- o Encampment movement and area restoration
- Updating the landscape asset management system

# **Discussion Topics**

Flowering Rush Waiver for Treatment

- WSDA needs a waiver from the Bureau of Reclamation to treat flowering rush on Lake Roosevelt, and asked the NWCB to hold this waiver.
- The board discussed the legal and logistical issues of doing this.
- Mary will work with the Attorney General, WSDA, and the board to fill out the most appropriate paperwork

### **Coordinators Forum**

- Eric Bell, Adams County Noxious Weed Control Board Pesticide test costs more, due to it moving online.
- Jennifer Mendoza, Cowlitz County Noxious Weed Control Board They have hired 2 inspectors. They need help funding for false brome and a few Class A species of thistles.
- Konrad Kauer, Benton County Noxious Weed Control Board They got a new office manager.
- Charles Edmonson, Lewis County Noxious Weed Control Board They are hiring a new education specialist. They are going to work on Knotweed and Egeria densa in 2024.
- Sophie DeGroot, Jefferson County Noxious Weed Control Board Have a new hire.

- Heidi Steinbach, Mason County Noxious Weed Control Board Was brand new at her position, so she was just figuring out budget and NPDES application.
- Craig Hintz, Grant County Noxious Weed Control Board They lost an inspector.
- Dale Whaley, Douglas County Noxious Weed Task Force Started work on rush skeleton weed.
- Larry Hudson, Okanagan County Noxious Weed Control Board Has started working on a lot of grant agreements, wildfire revegetation. They need more field techs, but just got one started.
- Christina St John, Clallam County Noxious Weed Control Board It was a warm winter on the
  peninsula, so they had been treating poison hemlock since January. They raised their
  assessment and were able to hire a new inspector. They have started renewing their lake
  management district.
- Jeff Nesbit, Pacific County Noxious Weed Control Board Have been focused on green crab rather than weeds, but knotweed, spartina, Scotchbroom and gorse work had started.
- Seth Luginbill, Island County Noxious Weed Control Board Their seasonal staff started in March. They are working on partnerships to reach lands that need treatment. They did their first enforcement. Poison hemlock has started already.
- Jeff Knutson and Sue Bird, Yakima County Noxious Weed Control Board They are hiring a new
  office manager. They will use seasonals instead of an inspector, for probably the next couple
  years.
- Jason Ontjes, San Juan County Noxious Weed Control Board Their staff has grown. They
  started working with Mary to redraw their weed regions. They started work on poison hemlock,
  shiny geranium, and tansy.
- Todd Harris, Franklin County Noxious Weed Control Board They could use more staff. They started spraying roads and getting cost shares up and running.
- Loretta Nichols, Pend Oreille County Noxious Weed Control Board Now have several grants and agreements in place, including a robust cost share program and herbicide trainings. They removed a lot of flowering rush. They hired new staff, but still have 2 open positions.
- Kiley Smith, Grays Harbor County Noxious Weed Control Board They were short-staffed over the winter, so she was working with agencies and crews to get projects done. A specialist has started, plus a couple technicians later in the season.
- Nate goodman, Klickitat County Noxious Weed Control Board It is only him for the whole county, but he is spraying and learning.
- Emily Stevenson, Skamania County Noxious Weed Control Board The county budget approved 2 new staff hires. The Columbia River Exotic Pest Workshop went great.
- Farren Reinbold, Lincoln County Noxious Weed Control Board Has interviewed for seasonals.
- Maddy Loy, Skagit County Noxious Weed Control Board Has interviewed for seasonals. They have started forming a lake management area.
- Julie Sanderson, Chelan County Noxious Weed Control Board They have lost two long time board members and are having a hard time finding replacements. Has done some hiring for field inspectors. They have 8 priority weeds to focus on this season. Grants are helpful, as their funding is assessment based. They have not done a lot of enforcements yet.
- Rochelle Osborne, Ferry County Noxious Weed Control Board Thanked the board for handling the flowering rush control funds. They are ready for applications once the snow melts.

• Mike Murphy, Thurston County Noxious Weed Control Board – They are hiring for a permanent position and seasonal positions. Spurge laurel inspections, gorse inspections, and lesser celandine treatments started.

# **Public Comment**

- Dale Whaley asked why Russian thistle isn't on the noxious weed list.
  - The board discussed that it is naturalised and widespread, so there isn't a budget that could handle it.
  - o Clallam county is starting to educate on it, and would like it to be listed as a Class C
