Office Reports

Mary and Anne summarized their work over the previous two months, which included several
presentations, meetings, sending out seed packets and publications, finalizing Class A contracts,
working on grant tracking for a Department of Ecology grant, finalizing the budget decision
packet, answering questions, and assisting counties and other groups.

Financial Report

- Mary summarized the most recent financial report, which included paying for the storage unit annual rent, moving funds from the supplies line to the Class A grants (as voted on by the board at the July meeting), and a few other typical small expenditures.
- Janet requested a training for the board members on how to read these expenditure reports, and it was discussed that it could happen in a 2025 board meeting, as it is not a pressing issue.

State Agency Updates

Washington State Department of Agriculture

 Alison summarized the recent work of the WSDA, which included that the budget request was sent to the legislature. She discussed the budget outlook, timeline, and what might help prioritize funding and getting supplemental requests.

Noxious Weed Committee

Marsh thistle, Cirsium palustre

Wild holly species, *Ilex species*

- Class C recommendation for non-native holly species the Noxious Weed Committee, with exemptions for plants found in managed landscapes, or where commercially or agriculturally grown.
- Anne summarized proposal, impacts, how to ID and how to control non-native holly species.
- It was asked if public comment could be made at this point. Allen stated that he wanted all public comment to be at the end, in the public comment section of the meeting.
- A potential meeting with Washington State senator Dent was discussed. This meeting would
 include some board members, holly growers, and proponents to a holly listing. Funding for holly
 farms or holly control could come out of this working group.
- Alison proposed to have what goes to hearing be for a wording change of wild holly, rather than non-native holly.
 - o Janet and Allen agreed with this change.

Education Committee

• Anne summarized the most recent education committee meeting, which discussed publication funding and reprinting needs, free herbicide credit webinars in the winter, free in person herbicide training in the spring, and legislative outreach.

Discussion Topics

WebEx versus Zoom

 Mary and the board discussed the technical issues with WebEx, and the pros and cons of using WebEx versus Zoom for meeting calls, webinars, and other needs.

- The consensus of the board was to switch to Zoom, rather than WebEx.
 - The November hearing and meeting may be in WebEx, depending on timing and filing needs.
 - o The December webinars will be held in Zoom.

Conference Room in Wenatchee

- Mary and the board discussed the November hearing and meeting space and technical needs and options to meet those needs in and around Wenatchee.
- The board asked Mary to research a few options and prioritize the cheapest or easiest location.

Printing funds and WSDA Spanish language course instructor pay

- Anne and the board discussed the publication reprinting and WSDA Spanish herbicide webinar instructor costs and needs
- The board reached consensus to provide up to \$500 to WSDA Spanish educators for the December free herbicide course

Board member elections

- Carey was reappointed by WSDA prior to this meeting.
- SW Washington district and Weed Districts are up for election
 - Nomination letters will go out at the end of September, ballots will go out at the end of October, and voting will be counted after the end of November.

Coordinators Forum

- Emily, Skamania County had a large crew this summer. With the cool weather they got a lot of scotchbroom control done. Knotweed and blackberry control will finish up the season. False brome was found on a remote gravel bar, and garlic mustard was reported by a landowner.
- Farren, Lincoln County had a great season. Their program assistant is retiring after 28 years, and hiring will occur soon.
- Steve, King County their level of control (between them and partners) is almost back at prepandemic levels.
- Sue and Jeff, Yakima they have found new willowherb infestations. They had a busy season.
- Gerry, Snohomish County has started a new position as a drainage inspector with Snohomish County, so her contact information is all the same. They have an interim coordinator until the job position opens in January.
- Wes, Washington State Department of Ecology got out to a lot of locations this season, with many partners.

Kodie Wight, Asotin County – had a great season. They partnered with the conservation district
and received funding from Rocky Mountain Elk Foundation and Fish and Wildlife for projects.
They surveyed and treated Mediterranean sage, 2 small knotweed populations, and hosted
some classes.

Public Comment

- 11:17
- Jim Rummel, Holly Hill Orchards owner Stated that he is waiting for new science to come, and they have been sent curveballs. He felt that researchers started with the result and worked backwards. He was unhappy with the "weed expert" definition in the laws. He stated he feels like he is being persecuted, and that if we dig down, we will find this is not real science and can't be repeated. He told the Attorney General in 2022 that new definitions and science can't be made willy nilly, and a listing would devastate his farm.
- John Rummel, Holly Hill Orchards manager summarized sections from the history portion of the holly written findings, about how children in Seattle would spread holly seed almost 100 years ago. He stated that he would have a 100% loss if holly was listed, and that he had a 50% loss in 2010, because Canada stopped buying holly, just because a vote on a holly listing.
- Alison (board member) responded that actions either way will cost money, and that the impacts are real to both sides.
 - She added that has a PhD in plant ecology, has read the science, data, and research is valid. Both the science and impact are real.
- Jim Rummel continued, beyond his 3-minute allotment, that potatoes are a widely planted crop in Whatcom County, but they aren't a noxious weed. He claimed that too much water or drilling holly with vinegar will both kill it.
- James Watson, Whidby Conservation District natural resource planner has done dendrochronological analysis on the age of holly in natural areas, and large trees can be dated to the 1960s. He has worked with Dave Stokes and confirms the invasive qualities of holly.
- Dendrochronological analysis on age of holly. Dated holly to 60s. worked with Dave stokes.
- Mary (board staff) stated that a lot of species were planted or introduced by well intentioned folks in the past, like the children in Seattle in the 1930's.
- Alaine (board member) asked if public comment is usually a discussion?
 - o Alison responded that public comment can be, while testimony is only recorded.
- Ken (board member, noxious weed committee member) stated that the board hasn't had any real discussions with the people involved.
 - Mary stated that in 2022 the committee held special holly meetings with those discussions, including at Ken's holly farm.
- Becky Chaney, King County Noxious Weed Control Board chair thanked the board members
 and would have liked to know that there was going to be a discussion, so she could have been
 more prepared. She has been in a forestry society for more than 10 years, and many folks in this
 group have problems with holly. She works with these small foresters, and every property she
 has been to has invasive holly growing on it. She regularly finds holly in her forest, and on her
 neighbor's property. She is worried about the fire danger holly poses, as large plants reach the
 canopy and are very oily and waxy.

- o John and Jim run Holly Hill Orchards
- o Alison works for WSDA
- o Ken is a board member, as well as a holly grower.
- Allen stated that no one is out to get anyone else, and that we are just trying to stop things from becoming worse.
